

CONSENT TO ADOPTION

Purpose: This is the document the natural parent(s) complete to consent to the adoption of his/her child or children.

Contents: This packet contains two documents:
a. Document 1: is used to secure the consent of the natural parents.
b. Document 2: is used to secure the consent of minor(s) over 12 years of age. This document does not need to be completed if the child is under 12 years of age.

How: This document is completed by the clerk of court, signed by the natural parent(s) and the judge.

Copies: This original document must be filed with the court. A copy should be retained by the natural parent(s).

Notes: The meaning and importance of this Consent should be thoroughly explained to and understood by the natural parent(s).

For additional information on consent to adoption, please see the Fort Peck Comprehensive Code of Justice of the Assiniboine and Sioux Tribes, TITLE X, Chapter 1, Section 105.
