

APPEAL

An appeal can be filed after a final civil or criminal judgment or order has been made. Temporary orders or denial of a motion cannot be appealed except where jurisdiction is in dispute. The Court may require the person seeking the appeal (appellant) to post a bond.

An appeal must be made within 15 working days from the date stamped on the upper right-hand corner of the judgment/order.

The appeal must state the reasons for seeking an appeal and what the appellant wants the Court to do.

At the time of filing the appeal, the appellant may want the judgment/order to be stopped while the appeal is considered. To do this, a motion for stay of judgment/order must be filed with the judge that made the judgment/order. A copy of the petition for appeal must accompany this motion.

If the judge denies the motion for a stay, the appellant can file a motion for a stay of judgment/order with the appellate court.

The cost to file an appeal is \$50.00. The other party to the action must be served with a copy of the petition for appeal and any motion.
